Goals of the Transport Best Practice



- Foster open relationships between source and destination agencies
- Improve the quality of transports minimizing animal stress and disease transmission
- Ensure that transport programs meet or exceed local, state and federal regulations pertaining to public health and animal safety
- Promote transport best practices to achieve the above
- Collect data on transports





Role of Transport



Address market demand

Highlight collective responsibility for animals

Drives placement for more animals

 Focuses on local, then regional, then national





Models for Transport




Agency to Agency

- Partnership capacity between Source and Destination agencies






Key Elements

- All agencies must be a 501(c)3 or a municipal agency
- All participants must commit to abiding by all local, state and federal regulations
- Humane standards of care must be afforded to every animal transported








Barriers to Transport
